On January 30th, 2010, at approximately 2056 hours, Trooper Tamra Winchell was seated in her patrol car on the side of the roadway in the Town of Darby when an intoxicated male driver crashed into her from behind, completely totaling the patrol car and seriously injuring Trooper Winchell.

Trooper Heaney was the first trooper to respond to the scene and conducted a tireless and thorough investigation which resulted in a successful felony conviction of the suspect. In addition, he took personal care of Trooper Winchell throughout her recovery period.

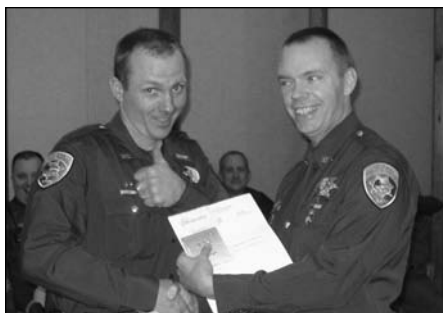
Sergeant Scott Hoffman (MHP 147) was presented with his fifteen year service stars by Captain Tom Hamilton.
